Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development hereby declare under Sub-Section (1) of section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.
