THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act:

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act:

The lands depicted as Lot “A” and “B” in Advance Tracing No. Nu/KTM/2007/294 and dated 13.12.2007 prepared by the Surveyor General and total extent of 0.2915 Hectare situated at Kumbaloluwa Village in Minor Division of Udapane Korallaya in the Divisional Secretary’s Division of Kotmale in the District of Nuwara Eliya in Central Province and bounded as follows:
