I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired :

Two (2) allotments of land called Nugawela watta, in total extent of about 0.094 Hectare depicted as Lot Nos. 37 and 38 in the Plan No. FVP 4, Sheet No. 11, Supplement No. 17, surveyed and prepared by the Surveyor-General, situated in the Village of Nugawela in Pannil Paththuwa Minor Division in the Divisional Secretary's Division of Kahawatta in Ratnapura District and bounded as follows:
