### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Seven (07) allotments of land called Kovilamudunawatta, Jambugahakotuwwawatta in total extent of about 0.1318 Hectare, depicted as Lot 'A' to 'G' in Advance Tracing No. Maha/PJP/2006/141 dated on 30.06.2006, surveyed and prepared by the Surveyor General situated in village of Kahawatta in Pallegampaha Korale Minor Division in the Divisional Secretary's Division of Pujapitiya in Kandy District and bounded as follows:

**1. Lot 'A' – Kovilamudunawatta, Jambugahakotuwwawatta – Extent: 0.0393 Hectare**
