#### THE LAND ACQUISITION ACT (CHAPTER 460) AS AMENDED BY THE LAND ACQUISITION (AMENDMENT) ACT, No. 28 OF 1964

##### Notice under Section 7.

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land which is required for a public purpose.

#### The land Acquisition for the reconstruction of the Bridge (Mile) No. 116/3 of Colombo - Hambantota Road.

##### Description of the land to be acquired.—
