NATIONAL WATER SUPPLY AND DRAINAGE BOARD ACT, No. 02 OF 1974

Order under Section 64(I)

BY virtue of the powers vested in me by Section 64(I) of the National Water Supply and Drainage Board Act, No. 2 of 1974, I, Ahamed Lebbe Marikkar Athaullah, the Minister of Water Supply and Drainage, do by this order embody in the Schedule hereto, the provision of the Voluntary Transfer Scheme approved by me under Section 63(1) of the aforesaid Law, in connection with the Haliela Morethota Water Supply Scheme maintained by the Haliela Pradeshiya Sabha.

SCHEDULE

Section 61(1) - Contents of the Voluntary Transfer Scheme:

- (a) All under mentioned movable and immovable property shall be vested the National Water Supply and Drainage Board, viz :-
- (i) All lands, buildings, pipelines, all mechanical and electrical machinery and equipment fixtures and all spares accessories and stores items required for the implementation and maintenance of all intakes refineries, pressure and balancing tanks and pumping stations of the Haliela Morethota Water Supply Scheme.
 - (ii) Servitudes over pipelines, spares, accessories and stores items along with all main pipelines and distribution pipelines required for the operation and maintenance of water distribution network of the Haliela Morethota Water Supply Scheme within the area of authority of the Haliela Pradeshiya Sabha.

- (b) Whatever contracts, rights obligations and liabilities entered into by the Haliela Pradeshiya Sabha in connection with the planning, supplies, fixtures, constructions, operation and maintenance in respect of the aforesaid property shall be vested in the Board.
- (c) All agreements entered into with the consumers of water in connection with the use and supply of water and all payments to be made in respect of the procurement of such services shall be transferred to the Board.
- (d) The Government shall award the value of such facilities amounting to Rs. 3,466,725.00 (Rupees Three Million Four Hundred and Sixty Six Thousand Seven Hundred and Twenty Five) as a grant to the Board.
- (e) The Board shall continue to maintain without interruption all agreement entered into by the Pradeshiya Sabha in connection with the provision of Water Supply Services and shall also fulfill such contractual obligation.

The aforesaid transfer shall come into operation with effect from the date of publication of this notice.
