TOWN AND COUNTRY PLANNING ORDINANCE (CHAPTER 269)

Order under Section 6 (2) (b) and Section 21 (2) (b)

BY virtue of the powers vested in me by Section 6 (2) (b) and Section 21(2)(b) of the Town and Country Planning Ordinance (Chapter 269), I, Dinesh Chandra Rupasinghe Gunawardena, Minister of Urban Development and Sacred Area Development, do by this order :—

- (a) declare that the area of land specified in the Schedule hereto shall be an Urban Development Area for the purpose of the aforesaid and shall be called the “Nawagamuwa Sacred Area” ;

and

- (b) direct that an outline scheme shall be prepared for the area declared to be the Nawagamuwa Sacred Area.

SCHEDULE

THE AREA OF LAND COMPRISING THE NAWAGAMUWA SACRED AREA

All that areas of land containing in extent 4.6108 Hectares and depicted in Survey General's Plan No. CO/KDW 2008/378, dated December 24, 2008, situated in the village of Nawagamuwa, within the Grama Niladhari Division of the Palle Paththuwa in the Divisional Secretary's Division of Kaduwela in the Administrative District of Colombo, in the Western Province and bounded as follows :-

North : by the land belonging to Liyanage and others, the land belonging to P. Gunarathna and others and the RDA Road ;

East : by the land known as Nawagamuwawatte belonging to K.N. Gamage and the Main Road belonging to the RDA ;

South : by the land known as Nawagamuwawatte belonging to K. N. Gamage and the land known as Denewakawatte belonging to E.D.D. Mitthrasena and others ;

and

West : by the land belonging to Liyanage and others, the land belonging to D.D. Gunarathna and the land known as Kurunduwatte belonging to W. Lionel and Others.
