THE OFFICIAL SECRETS ACT (CHAPTER 39)

Order under Sub-section (1) of Section 2

BY virtue of the powers vested in me by Sub-section (1) of Section 2 of the Official Secrets Act, (Chapter 39), read with paragraph (2) of Article 44 of the Constitution, I, Mahinda Rajapaksa, President, do by this order declare that :-

- (a) the area of land comprising the Kikiliyamana Mountain Range specified in the Schedule to this Order shall be a Prohibited Place for the purposes of the aforesaid Act ;
- (b) the Secretary to the Ministry of the Minister in charge of the subject of Defence shall be the Competent Authority for the purposes of this Act ;
- (c) no person, other than a person to whom the Competent Authority has in terms of Section 15 issued a permit, may enter or remain within the aforesaid Kikiliyamana Mountain Range Prohibited Place ; and
- (d) any person authorized to enter or remain within the Kikiliyamana Mountain Range Prohibited Place shall within such place engage only in such purpose and subject to such conditions as shall be specified in the permit.

SCHEDULE

LIMITS OF THE KIKILIYAMANA MOUNTAIN RANGE PROHIBITED PLACE

The area of land comprising the Kikiliyamana Mountain Range Prohibited Place shall be as depicted in Survey Plan No. D/Ko/1151/2008 dated 06.09.2008, situated in the Divisional Secretary's Division of Nuwara Eliya, in the Administrative District of Nuwara Eliya in the Central Province and shall be bounded as follows :-

North : by the Main road (Road Development Authority) the land depicted as Lot 20 on PPN 371, West Ward HO Estate (TP 60073), West Ward HO Estate (TP 160623), the Ela and the land depicted as Lot No. 1 (Folio 2) in TSP No. 42 ;
