#### FILLING OF A VACANCY IN THE OFFICE OF A CHAIRMAN OF THE KAHAWATTE PRADESHIYA SABHA UNDER SECTION 65A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)
