Finance Statute No. 13 of 1990

ORDER UNDER SECTION 7(1)

- (i) In respect of the turnover of the business of selling or buying and selling any article or commodity other than any business referred to under items (a), (b), (c), (d), (e), (f), (g) (h), and (i) above. 01 *Per centum*”
