### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Thirteen (13) allotments of land in extent about 0.1828 Hectare, depicted in Advanced Tracing No. Ku/KRN/2007/72 and dated 06th April, 2007, prepared by the Surveyor Superintendent of Kurunegala District, situated in the village of Wehera in Minor Division within the Municipal Council Limits of Kurunegala in Ward No. 12, Wehera of Divisional Secretary's Division of Kurunegala in Kurunegala District in North Western Province and bounded as follows:
