FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE KADUWELA PRADESHIYA SABHA UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

**FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE ADDALAICHENAI PRADESHIYA
SABHA UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE
(CHAPTER 262)**

WHEREAS the office of a member in Addalaichenai Pradeshiya Sabha has fallen vacant by reason of being elected as a member of the Eastern Province Provincial Council ;

And whereas the Secretary of the United Peoples Freedom Alliance the recognized political party to which M. S.
