MOTOR TRAFFIC ACT (CHAPTER 203)

REGULATIONS made by the Minister of Transport under section 237 of the Motor Traffic Act (Chapter 203), read with Sections 123, 124, 125, 126, 126B, 128 and 231 of the aforesaid Act.

Regulations

1. These regulations may be cited as the Driving License (Levy) Regulations, No. 01 of 2009. The levies specified in these regulations shall be operative with effect from 27th March, 2009.
2. The levies payable in respect of Normal Service and Same Day Service for -
 - (a) the issue of a New Regular Driving License;
 - (b) the renewal (extension of validity period) of a Regular Driving License;
 - (c) the issue of a Duplicate of a Regular Driving Licence;
 - (d) change of particulars of a Regular Driving License;
 - (e) conversion from existing driving license to New Driving License;
 - (f) conversion from foreign driving license to New Driving License and *vice versa*;
 - (g) the issue of a Regular Driving License to a foreign citizen;
 - (h) the issue of an Extract of a driving License;
 - (i) the issue of a Driving License Permit for one month; and
 - (j) the issue of an International Driving License.

shall be as specified in Column II and Column III of the Schedule to these regulations.
