FILLING OF A VACANCY IN THE OFFICE OF CHAIRMAN OF THE TANAMALWILA PRADESHIYA SABHA UNDER SECTION 65A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of Chairman in Tanamalwila Pradeshiya Sabha has fallen vacant by reason of being elected as a member of the Uva Province Provincial Council ;
