#### **FILLING OF A VACANCY IN THE OFFICE OF CHAIRMAN OF THE HIKKADUWA URBAN COUNCIL UNDER SECTION 65A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)**

WHEREAS the office of Chairman in Hikkaduwa Urban Council has fallen vacant by reason of not attending more than three consecutive meetings without permission ;
