I hereby give notice under Sub section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Acquired for the purpose of Arthivusa Vidyalyaya.

Description of the land to be acquired:

Allotments of lands in extent about 0.0955 Hectares, in plan No. 7268, dated 1996.10.02 prepared by the licensed Surveyor. Lot Nos. 3512 and 3513, situated in the village of Wellawatta, No. 45, Pamankada West Grama Niladhari's Division within the Colombo Municipal Council in the Divisional Secretary's Division of the Thimbirigasyaya in Colombo District in Western Province and described as follows:
