## PART I : SECTION (I) — GENERAL

TOURISM ACT, No. 38 OF 2005

Order under section 53

BY virtue of the powers vested in me by sub-section (1) of section 53 of the Tourism Act, No. 38 of 2005, I, Bernard Anton Bandara Goonetilleke, Chairman, Sri Lanka Tourism Development Authority do by this Order, fix the prices specified in the Schedules I and II which shall be the minimum rates that shall be demanded or recovered from each occupant in respect of charges for the occupancy of a room and for meals which may be provided to such occupancy in tourist hotels within the limits of the area of authority of the Colombo Municipal Council and the Dehiwala Mount Lavinia Municipal Council. The rates specified in Schedule I shall be effective from November 1, 2009, and the rates specified in Schedule II shall be effective from January 1, 2011.

For the purpose of this Order, tourist hotel means an establishment which has been registered, licensed and classified by the Sri Lanka Tourism Development Authority as a tourist hotel, on the date this Order comes into operation and any other establishment that would be registered and licensed as such, after this order comes into operation.

##### Category I
