Rules

The rules published in *Gazette Extraordinary* No. 305 of July 6, 1984, as amended from time to time and last amended by rules published in *Gazette Extraordinary* No. 1502/16 of June 20, 2007 are hereby further amended as follows :-

- (1) in rule (3), in sub-paragraph (1) of paragraph 5 thereof, by the substitution for the word and figures “rupees 10” of the word and figures “rupees 50” ;
- (2) in rule (14), in sub-paragraph (a) of paragraph 2 thereof, by the substitution for the word and figures “rupees 50,000” of the word and figures “rupees 100,000” ;
- (3) in rule (15) —
 - (a) in sub-paragraph (a) of paragraph 1 thereof, by the substitution for the word and figures “rupees 17,500” of the word and figures “rupees 20,000” ; and
 - (b) by the substitution for sub-paragraph (b) of paragraph 1 thereof of the following—

“(b) Upon a written request by the member a member shall be paid rupees 17,500 as death gratuity in the event of the death of a parent, parent of the spouse or a child at birth.” ;
- (4) in rule (19) —
 - (a) in paragraph 1 thereof, by the substitution for the words and figures “Rupees Five Thousands (Rs. 5,000)” and “Thirty Thousands (Rs. 30,000)” of the word and figures “Rupees Seven Thousand Five Hundred (Rs. 7,500)” and “Forty-five Thousand (Rs. 45,000)” ;
 - (b) in paragraph 4 thereof, by the substitution for the words and figures “Rupees One Thousand Two Hundred (Rs. 1200) per annum at the rate of rupees one hundred (Rs. 100) per month.” of the words and figures “Rupees One Thousand Eight Hundred (Rs. 1800) per annum at the rate of Rupees One Hundred Fifty (Rs. 150) per month.” ;
- (5) in rule (22) —
 - (a) by the repeal of paragraph 1 thereof and the substitution therefore of the following :-

“1. Upon a member completing one year as such member, he shall be entitled to a special loan in such amount as correspondence to the period of his membership as is set out below :

No.	Period of membership (In years)	Amount of Loan (Rupees)
1	01 — 05	7,500
2	05 — 10	10,000
3	10 — 15	15,000
4	15 — 20	20,000
5	Over 20	25,000 ; and

(b) by the repeal of Schedule to the paragraph (5) thereof, and the substitution therefor of the following :-

(6) in rule (25), by the substitution for the words and figures “not exceeding One Thousand rupees (Rs. 1.000) ” of the word and figures “not exceeding Two Thousand Five Hundred rupees (Rs. 2,500) ” ; and

(7) in rule (39) in paragraph (2) thereof, by the substitution for the word and figures “rupees 150” of the word and figures “rupees 500” ;
