THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Twenty (20) allotments of land in total extent of about 3.9122 Hectares, depicted in Advance Tracing No. KU/WRY/2007/320 and dated 31st March, 2008, prepared by the Surveyor-General, situated in the village Vaduressa (F.V.P. 2687), in Sub-division of Devamedhi Korale in the Divisional Secretary's Division of Wariyapola in Kurunegala District in North Western Province and bounded as follows:

North: Lots N and M; East: Lots M, BZ, BY, of advance Tracing No.KU/WRY/2007/214 and Lot R; South: Lots R and S; West: Lots S, P and N.

14. Lot 'R' – Moragaha Ulupoththewela – Extent: 0.1401 Hectare

North: Lots Q, M, BZ and By of advance Tracing No.KU/WRY/2007/214; East: Lots BY, BW of advance Tracing No.KU/WRY/2007/214 and Balance portion of this land; South: Balance portion of this land, Paddy field belongs to M. M. Ananda Herath, Lots U and T; West: Lots T, S and Q.

THE LAND ACQUISITION ACT (CHAPTER 460)**Declaration under Section 5**

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Ten (10) allotments of land in total extent of about 0.7069 Hectares, depicted in Advance Tracing No. KU/WRY/2007/183 and dated 31st March, 2008, prepared by the Surveyor-General, situated in the village Waduressa (F.V.P. 2687) in Sub-division of Devamedia Korale in the Divisional Secretary's Division of Wariyapola in Kurunegala District in North Western Province and bounded as follows:
