THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the Land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Nine (09) allotments of land in total extent of about 0.1836 Hectare, depicted as Lot Nos. 01 to 09 in Advance tracing No. Gam/saja/2008/66 of 15th September 2008 prepared by the Surveyor-General and situated in Bandarawatta village in Minor Division of Siyane Korale in the Mahara Divisional Secretary's Division in the District of Gampaha in Western Province and bounded as follows:
