#### **ANNOUNCEMENT OF COMBINING AND CONFIRMING HOUSING RENT BOARDS AUTHORITY AREA IN THE CENTRAL PROVINCE PROVINCIAL COUNCIL**

I, Bandula S. B. Yalagama, Minister of Road Development, Power & Energy, Housing and Constructions in the Central Province Provincial Council, by virtue of powers vested in me by the Sentence No. 38(3) in the Act of housing rent, No. 07 in 1972 amended by the Act, No. 55 in 1980 (amendment) and Act, No. 26 in 2002 (amendment) read with the Provincial Council (consequent provisions) Act, No. 12 in 1989, hereby declare that housing rent boards in the Central Province should be combined as follows. Accordingly, notify to refer statements and other complaints of house owners and tenants to Chairman/Secretary of respective housing rent boards and relevant investigations will be held in the offices shown in the Schedule.

##### **01. Combining boards of housing rent**
