STATEMENT OF MATTERS IN DISPUTE

The matters in dispute between the aforesaid parties are

1. Whether any injustice was caused to Mr. P. M. Thilak Pushpakumara who is in the service as a Store Keeper Grade III under the Lanka Salt Limited due to offering him the post of Audit Clerk Grade III from 01.07.2002 where as the said post should have to be granted to him as effective from 01.07.1999 and if any injustice was caused, to what relief he is entitled;
2. Whether the demand made by Mr. P. M. Thilak Pushpakumara that he be appointed to the post of Store Keeper Grade III by taking into account of the fact that he had completed a period of four (04) years in the post of Store Keeper Grade IV and if so, what relief he should be granted;
3. Whether Mr. P. M. Thilak Pushpakumara is entitled to receive the arrears of 20% difficult station allowance for the period of December 2006 to December 2007 and to what relief he is entitled

AND

4. Whether it was justified to transfer Mr. P. M. Thilak Pushpakumara to Palatupana Lewaya from Hambantota with effect from 05.12.2006 is justified and if not justified, to what relief he is entitled.
