SRI LANKA ELECTRICITY ACT, No. 20 OF 2009

Order under Section 52

BY virtue of the powers vested in me by Section 52 of the Sri Lanka Electricity Act, No. 20 of 2009, I, Mahinda Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka, do hereby, upon the recommendation of the Minister-in-charge of the subject of Power and Energy, being of the opinion that –

- (a) the lands specified in the Schedule hereto are urgently required for the construction of a Power Transmission Project, and
- (b) the said Power Transmission Project being a public purpose would serve for the general welfare and benefit of the public,

declare that the said lands are required for such purpose.
