THE AWARD

CORRECTION OF AWARD IN CASE No. A/3004 UNDER
REGULATION 29 OF THE INDUSTRIAL DISPUTES
REGULATIONS 1958

I Notice a few clerical errors due to an over-sight appearing in the Award published in the *Gazette Extraordinary* No. 1397/26 dated 15th June, 2005, I do hereby correct the paragraph commencing from the words “I holdand ending onthe date hereof”.

To read as follows :—

“I hold that on the documents marked by the applicant workman namely A1, A2, A3, A4, A5 and A6 and the evidence of the applicant as follows :-

1. That the 2% commission on achievement of target for January 2000 is Rs, 26,464/- and that the applicant workman is entitled to it.

2. That the car rental was Rs. 20,000 per mensem and that he is entitled to the car rental for the month of April and May 2000 amounting to Rs. 40,000.

I make award that Mr. D. Nugawela and S. Nugawela pay the sum of Rs. 66,464 to the applicant workman Thilan Senaratne.

The employers to deposit the money awarded hereby with the Commissioner General of Labour within one month from the date of publication of this award in the Gazette.

This award shall take effect from the date hereof.”
