Notice under Section 277 of the Municipal Councils Ordinance (Chapter 252) read with Section 3 of the Powers of Supervision of the Administration of Local Government Authorities Statute No. 04 of 1990 of the Provincial Council and Section 2 of the Provincial Councils (Ancillary Provisions) Act, No. 12 of 1989.
