THE Award transmitted to me by the Arbitrator to whom the Industrial Dispute which has arisen between Commercial And Industrial Workers Union, 17, Barrack Lane, Colombo 02 of the one part and Unilever Ceylon Limited, 258, M. Vincent Perera Mawatha, Colombo 14 of the other part was referred by order dated 17.07.2006 under Section 4(1) of the Industrial Disputes Act Chapter 131 (as amended) and published in the *Gazette* of Democratic Socialist Republic of Sri Lanka Extraordinary, No. 1458/12 dated 16.08.2006 for settlement by Arbitration is hereby published in terms of Section 18(1) of the said Act.

The Honourable Minister of Labour Relations and Foreign Employment by virtue of the powers vested in him by section 4(1) of the Industrial Disputes Act, Chapter 131 of the Legislative Enactments of Ceylon (1956 Revised Edition) as

amended by Act, Nos. 14 of 1957, 4 of 1962 and 33 of 1968, (read with Industrial Disputes Special Provisions Act, No. 37 of 1968), has appointed me as the Arbitrator and referred the following dispute for settlement by Arbitration.

"whether the deduction of 1% from the annual salary increment of 802 employees of Unilever Ceylon Limited whose names are referred to in the attached Schedule and withholding of their service increments and reduction of their annual leave by the Company having considered that the period from 05.05.1998 to 20.5.1998 (excluding weekends) during which the said employees had joined the strike as members of the Commercial and Industrial Workers Union as no pay absenteeism is justified, and if not, to what relief the said employees are entitled".

AWARD

The Applicant Party of the First Part (hereinafter called the Applicant) stated that the above reference was initially made by the Hon. Minister to the Hon. Arbitrator Mr. A. N. D. Balasuriya and later the Hon. Minister deemed it expedient to revoke the said order and refer the same dispute to the present Arbitrator to settle the dispute by arbitration.

The Applicant Union stated that the company had introduced a new system of work to which the workers objected and on 05.05.1998 the workers struck work and the Union had informed the Commissioner of Labour of the strike action. Subsequently on 20.05.1998 they had arrived at a settlement which was embodied in a Memorandum of Settlement under section 12(1) of the Industrial Disputes Act and the workers returned to work. Subsequently, a Collective Agreement was signed on 25.09.1998.

The Union said further that the 1% annual salary increment and the service increment due to the workers was not paid even as at 01.01.1999 and the Company reduced the annual leave component of the workers for the days on which they had gone on strike considering those days as no pay leave.

The Union had made representations to the Commissioner of Labour and the latter had advised the Company to pay the annual leave increment and the annual leave.

The Union further submitted that what had been agreed was that for the period of the strike no payment be made and not to consider the days of the strike as no pay leave for the purpose of determining the annual increment. The Union contends that the withholding of the service increment and the reduction of the annual leave by the Company by considering the days of the strike period as days of no pay leave is unreasonable and illegal.

The Union therefore prays that the Company be held to be unjustified in considering the period of the strike from 05.05.1998 to 20.5.1998 as no pay absenteeism and order the company to restore the 1% to the annual increment and also restore the service increment and the annual leave.

The Respondent Party of the Second Part (hereinafter called Unilever) stated that the workforce in the factory resorted to strike action on 05.05.1998 and on 20.05.1998 the strike was resolved amicably and a Memorandum of Settlement was reached in terms of section 12(1) of the Industrial Dispute Act. Unilever in its submissions stated that it was specifically stipulated that the period of the strike from 05.05.1998 to 20.05.1998 will be treated as no pay. Subsequently a Collective Agreement was signed between Unilever and the Applicant Union on 25.09.1998.

In January 1999 when Unilever announced the Annual Increments the Applicant Union raised a dispute on the ground that Unilever had violated the Collective Agreement and the terms of the Memorandum of Settlement, Since this dispute could not be resolved this matter was referred to Arbitration No. 2971 and since the Arbitrator was not available, it had now been referred to the present Arbitrator.

Unilever states that the Union's argument has been that Unilever had violated the terms and conditions laid down in the Memorandum of Settlement signed under section 12(1) of the Industrial Disputes Act.

Unilever further states that the Union cannot maintain that there has been a breach of the provisions of the Memorandum of Settlement and in any event it falls outside the arbitration process as set out in the Industrial Disputes Act.

Proceedings

This matter was taken up for inquiry on 28.09.2006 and concluded on 04.11.2009 with written submissions being tendered by both Parties.

In February 2007 Unilever filed a preliminary objection on the basis that the reference to the arbitration is bad in law on the ground that there is a difference in the words used in the English version of the reference as against the Sinhala version. Written submissions were filed by both Parties.

Unilever in filing their submissions stated that there is a blatant error in the Sinhala and English versions of the Reference. They argued that the Sinhala version states that the Company had deducted 1% of the annual increment on the basis of 'no pay leave' whereas the English version describes it as 'no pay absenteeism'.

The Arbitrator overruled this objection firstly on the ground that according to the plain meaning in both versions of the Reference, Unilever had deducted 1% of the annual salary increment for the period 05.05.1998 to 20.05.1998 (excluding weekends) when the employees belonging to the Applicant Union were away from work participating in a strike.

Secondly, the Arbitrator pointed out that Unilever had confused itself in translating the term 'no pay leave' in the Sinhala version of the reference into English as 'no pay leave' as against 'no pay absenteeism' in the English version of the Reference. It was also pointed out that Unilever refers to the English version of the Reference as 'no pay absence' where the connotation is very different from the meaning in 'no pay absenteeism'.

The arbitrator also pointed out that the simple meaning of the word 'absenteeism' in any standard English dictionary meant 'absenteeism' as staying away from the workplace without permission and this would mean that such a person would not be entitled to pay for these days. He also pointed out that the simple meaning of 'leave' is 'being away from the usual place of work where formal leave of absence has been granted'. Therefore 'no pay leave' will mean that a person is away from the usual place of work on formal leave but without pay as a specific of this leave.

Therefore the Arbitrator ruled that the Sinhala version 'no pay leave' and English version 'no pay absenteeism' convey the same meaning and that there is no error in the Sinhala and English versions of the Reference. Therefore, the Reference is not bad in law.

It was also pointed out by the Arbitrator that the Reference does not presuppose the fact of the strike and both Parties have admitted this. Also there is no presupposition in the Reference that 1% had been deducted on the basis of the strike.

It was also pointed out that the Reference is outside the purview of the Arbitrator as he is a creation in terms of Section 4(1) of the Industrial Disputes Act and is appointed by the Minister notwithstanding that the Parties to such dispute do not consent to such reference. In the circumstances the objections raised by Unilever were over ruled.

AWARD

The main matter in dispute in the Reference made to arbitration is the question of the period of the strike of the employees between 05.05.1998 to 20.05.1998 (excluding weekends). The question centered around the words 'no pay' and 'no pay absenteeism'. In terms of clause 16 of the Settlement under 12(1) of the Industrial Disputes Act, it was intended that the period of the strike be treated as 'no pay'. The question that arises is what the nature of the 'no pay' is. Could it mean 'no pay' absence or 'no pay absenteeism'? In both connotations, the reference is to absence during the

period of the strike. If this is so, was the period of the strike authorized by the management as a period of absence or not? In this situation if we refer to clause 8 of the Agreement signed between Unilever and the Commercial and Industrial Workers Union on 02.09.1998 which stipulates that those who have been absent without due authority and on being placed on no pay absence in the preceding year will only be entitled to the annual increment of 3% as against the normal annual increment of 4% from 1st January 1998.

It is clear from the evidence led and the submissions of both Parties that the said period of absence was considered as no pay amounting to no pay absence. It is clear that these employees will be entitled only to 3% annual increment due to their absence during the period of the strike resulting in a 1% deduction in their annual salary increment.

One of the factors that transpired during this inquiry was that not all the 802 employees listed in the reference were employees who participated in the said strike. Neither Party made any effort to clarify this position and inform the Arbitrator of the real position. In these circumstances, it is difficult to make an award since no details were given about the service of these employees. Therefore Unilever is entitled to act in terms of clause 9 of the Agreement to decide on service increments in the case of these employees. This could be determined in consultation with the Union and in terms of clause 9 of the said Agreement.

Finally, with regard to the reduction of the annual leave of the workers who were on strike during the period 05.05.1998 to 20.05.1998, since Unilever did not consent to or authorize the said strike they are entitled to deduct the period of the strike from the annual leave of the striking workmen.

In the circumstances the following awards are made:-

1). That Unilever is entitled to the deduction of 1% from the annual salary increment of the striking workers;

2). Unilever is within its rights to withhold their service increments and

3). Unilever is entitled to the reduction of the annual leave of the workers who participated in the strike between 05.05.1998 and 20.05.1998.

These Awards should be implemented within one month of the publication of these Awards in the Government *Gazette* of the Democratic Socialist Republic of Sri Lanka.
