PART I : SECTION (I) – GENERAL

Government Notifications

THE PRADESHIYA SABHAS ACT, No. 15 OF 1987

Order

By virtue of the powers vested in me by sections 2, 4 and 6 of the Pradeshiya Sabhas Act, No. 15 of 1987, I, A. L. M. Athaullah, Minister of Local Government and Provincial Councils, do by this Order –

- (1) declare the area specified in Part I of the Schedule hereto, to be a Pradeshiya Sabha area for the purpose of that Act ;
- (2) define the administrative limits of that Pradeshiya Sabha area to be limits as set out in Part II of that Schedule ;
- (3) constitute a Pradeshiya Sabha for the Pradeshiya Sabha area declared under paragraph (1) of this Order and assign the following name to such Sabha :–

“Lunugala Pradeshiya Sabha”;

- (4) determine that the Lunugala Pradeshiya Sabha shall consist of the Chairman, Vice Chairman and nine other elected members ;
- (5) appoint the first day of April, 2011 as the date on which the term of office of the Lunugala Pradeshiya Sabha shall commence.

PART I

The area of land comprising of the following Grama Niladari Divisions in the Lunugala Divisional Secretary's Division in the Badulla District :—

PART II

Administrative Limits of the Lunugala Pradeshiya Sabha :

North :

Beginning by a line drawn from the point where the Northern boundary of Passara Divisional Secretary's Division meets the common boundary of the Meegahakivula and Lunugala Divisional Secretary's Divisions Northwards, Eastwards, North - Eastwards and South - Eastwards along the common boundary of Lunugala and Meegahakivula Divisional Secretary's Divisions up to the point where it meets the common boundary of Monaragala and Badulla Districts, thence South - Eastwards and Eastwards along the said common boundary up to the point where it meets the Northern Boundary of the Medagama Divisional Secretary's Division in Monaragala District ;

East :

By a line drawn from the last mentioned point Southwards along the common boundary of Monaragala and Badulla Districts up to the point where it meets the centre line of the Kumbukkan Oya ;

South :

By a line drawn from the last mentioned point Westwards along the common boundary of Monaragala and Badulla Districts up to the point where it meets the boundary of Passara Divisional Secretary's Division, thence Westwards along the common boundary of Passara and Lunugala Divisional Secretary's Divisions up to the point where it meets the Eastern and Southern boundaries of (89E) Maligathenna Grama Niladhari Division of the Passara Divisional Secretary's Division ;

West :

By a line drawn from the last mentioned point Northwards along the common boundary of Passara - Lunugala Divisional Secretary's Divisions up to the starting point.

THE PRADESHIYA SABHAS ACT, No. 15 OF 1987

Order

By virtue of the powers vested in me by Paragraphs (a) and (b) of section 9A of the Pradeshiya Sabhas, Act, No. 15 of 1987, I, A. L. M. Athaullah, Minister of Local Government and Provincial Councils, do hereby amend the Order published in *Gazette* Extraordinary, No. 453/25 of May 12, 1987 relating to the constitution of the Passara Pradeshiya Sabha, as follows :—

- (1) (a) by the deletion of Schedule thereto and substitution of Schedule hereto ;
(b) by the repeal of the word “Twenty” in the fourth paragraph of the said Order and the substitution of the word “Nine” ;
- (2) The above Order shall come in to force with effect from the first day of April, 2011.

PART II

Administrative Limits of the Passara Pradeshiya Sabha :

North :

Beginning by a line drawn from the point where the common boundary of Soranatota and Passara Divisional Secretary's Divisions meets the common boundary of Meegahakivula and Passara Divisional Secretary's Divisions, North - Eastwards along the common boundary of Meegahakivula and Passara Divisional Secretary's Divisions up to the point where it meets the Passara and Lunugala Divisional Secretary's Divisions, thence South - Eastwards and North - Eastwards along the common boundary of Lunugala - Passara Divisional Secretary's Divisions up to the point where it meets the centre line of the Madolsima - Peessegama road,

East :

By a line drawn starting from the last mentioned point Southwards along the common boundary of Lunugala - Passara Divisional Secretary's Divisions up to the point where it meets the common boundary of Monaragala - Badulla Districts, thence South - westwards along the said District boundary up to the point where it meets the centre line of Passara - Monaragala road ;

South :

By a line drawn from the last mentioned point South - westwards along the boundary of Badulla - Monaragala Districts up to the point where it meets the Eastern boundary of Ella Divisional Secretary's Division ;

West :

By a line drawn from the last mentioned point Northwards along the common boundary of Ella - Passara Divisional Secretary's Divisions up to the point where it meets the Southern Boundary of the Hali-Ela Divisional Secretary's Division, thence Northwards along the common boundary of Hali-Ela Passara Divisional Secretary's Divisions up to the point where it meets the Southern boundary of Badulla Divisional Secretary's Division, thence Northward along the common boundary of Badulla - Passara Divisional Secretary's Divisions up to the starting point.
