THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Chamal Jayantha Rajapakshe, Minister of Agricultural Development do hereby declare under sub section (1) of Section 5 of the Land Acquisition Act, that the Land described hereunder is required for a public purpose and will be acquired under the provisions of that Act.

Description of Servitude :

To connect to the Water Treatment plant Main Pipeline of the Kalani South Bank Water Supply Scheme.
