Order under Section 4(a) 1

BY virtue of the powers vested in me under Section 4(a)1 of the Sri Lanka Land Reclamation and Development Corporation Act, No. 15 of 1968 as amended by Act, No. 27 of 1976, Act, No. 52 of 1982 and Act, No. 35 of 2006, I, Dinesh Gunawardhana, Minister of Urban Development and Sacred Area Development with the consultation with the respective Local Government Institutions do by this order declare the areas specified in the schedules 01 to 45 hereto be a canal reservation area. Terms and Conditions prescribed by the Land Reclamation and Development Corporation have to be adhered to in carrying out any activity in this area.
