THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below, is needed for a public purpose, and will be acquired under the provisions of that Act.

Allotments of land (A to H, J to V) in total extent of about 3.019 Hectares depicted in Advance Tracing No. H/TNG/2006/195 and dated on 31.07.2006 prepared by the Surveyor-General situated in the village of Kattakaduwa (F.V.P. 329) Kotawaya (F.V.P. 332) of the South Giruwapattu Minor Division in the Divisional Secretary's Division of Tangalle, Angunakolapalassa in Hambantota District and bounded as follows:
