FILLING OF A VACANCY IN THE OFFICE OF VICE CHAIRMAN OF THE ADDALACHCHENAI PRADESHIYA SABHA UNDER SECTION 65A (1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the Office of Vice Chairman in Addalachchenai Pradeshiya Sabha has fallen vacant by reason of failing to make and subscribe an Oath or Affirmation in terms of the Seventh Schedule of the Constitution of the Democratic Socialist Republic of Sri Lanka ;

And whereas the Secretary of the Sri Lanka Muslim Congress the recognized political party to which Umar Lebbe Aboobucker the Vice Chairman belonged, was required by me under Section 65A (1) of the aforesaid Ordinance, to decide upon the member of that Addalachchenai Pradeshiya Sabha who belongs to such party who shall be declared elected as Vice Chairman within a period of thirty (30) days ;

And whereas the Secretary of the aforesaid Recognized Political Party has communicated his decision to nominate Mr. Mohamed Ameer Anzil being an eligible person under the aforesaid Ordinance to fill such vacancy ;

Now therefore, I, Tennekoon Mudiyanseelage Laxmendra Damayanthkumara Tennekoon, Returning Officer of Addalachchenai Pradeshiya Sabha, acting in terms of Section 65A(1) of the Local Authorities Elections Ordinance (Chapter 262) do hereby declare Mr. Mohamed Ameer Anzil elected as Vice Chairman of the Addalachchenai Pradeshiya Sabha.

**FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE ADDALACHCHENAI PRADESHIYA
