Declaration under Section 5

I, Chamal Jayantha Rajapaksha, Minister of Agriculture Development hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

The land marked as Lot 'A' and 'B' in Advance Tracing No. KA/SPO/05/388 and dated 06.03.2006 repurchased from Advance Tracing No. KA/BRW/94/352 and KA/BRW/03/213 prepared by Surveyor-General of Kalutara, situated at village of Diyalagoda in Minor Division of Kalutara Thotamuna - North in Divisional Secretary's Division of Beruwala in the District of Kalutara and containing in extent about 0.0378 Hectare and bounded as follows:
