SABHA UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS
ORDINANCE (CHAPTER 262)**

WHEREAS the office of a member in Alayadivembu Pradeshiya Sabha has fallen vacant by reason of not attending meetings of the Council for a period of three months without permission ;
