Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Description of the land to be acquired :

Seven (07) allotments of land in total extent of 0.0912 Hectare, depicted as Lots 'A' to 'G' in Advance Tracing No. Maha/UDN/2006/293, dated on 07th August, 2006, surveyed and prepared by the Superintendent of Surveys of Kandy District, situated in the Village of Hiddaula Hiyarapitiya in Medapalatha Korale Minor Division in the Divisional Secretary's Division of Udunuwara in Kandy District and bounded as follows :

01. Lot 'A' – Deyyange Pihille Hena – Extent: 0.0127 Hectare

North and East: Remaining portion of the said land; South: Lot B and remaining portion of the said land; West: Part of Lot No. 6 of PP Maha. 7862.

02. Lot 'B' – Deyyange Pihille Hena – Extent: 0.0506 Hectare

North: Lot A and remaining portion of the said land; East: Remaining portion of the said land; South: Part of Lot No. 7 1/2 in PP Maha. 4070 and Lot C; West: Part of Lot No. 6 of PP Maha. 7862.

03. Lot 'C' – Dangollahena – Extent: 0.0074 Hectare

North: Lot B and remaining portion of the said land; East: Remaining portion of the said land; South: Lot D and G; West: Lot G and part of Lot No. 6 of PP Maha. 7862.

04. Lot 'D' – Dangollahena – Extent: 0.0032 Hectare

North: Remaining portion of the said land; East: Remaining portion of the said land and Lots E and F; South: Lot G; West: Lot C and remaining portion of the said land.

05. Lot 'E' – Dangollahena – Extent: 0.0016 Hectare

North: Remaining portion of the said land; East: Road; South: Lots F and G; West: Lot D and remaining portion of the said land.

06. Lot 'F' – Dangollahena – Extent: 0.0024 Hectare

North: Lot E; East: Road and remaining portion of the said land; South: Remaining portion of the said land; West: Lots G and D.

07. Lot 'G' – Dangollahena – Extent: 0.0133 Hectare

North: Lots C, D and E; East: Lots E and F; South: Remaining portion of the said land; West: Lot No. 6 of PP Maha. 7862.
