NATIONAL FILM CORPORATION OF SRI LANKA ACT, No. 47 of 1971

REGULATIONS made by the Minister of Cultural Affairs under Section 61 and Section 5 of the National Film Corporation of Sri Lanka Act No.47 of 1971 as amended by Act No. 45 of 1980.

REGULATIONS

Reference notice of the National Film Corporation (Distribution of Films) Regulation No. 2 of 2007, published in *Gazette Extraordinary* No. 1499/17 of 30th May, 2007, are hereby amended as follows :

In regulation 2 of thereof—

by the repeal of paragraphs (1), (2) and (3) and substitution of the following paragraphs thereof—

2. (1) The National Film Corporation of Sri Lanka (hereinafter referred to as the “Corporation”) shall distribute the films within Sri Lanka.
- (2) While distribution of films shall be done by the Corporation in order to maintain systematic functioning of distribution, Exhibiting Circuits may be established in the private sector.  
However the maximum number of such circuits shall be limited to five.
- (3) The Chairman of the National Film Corporation of Sri Lanka (hereinafter referred to as the “Chairman”) shall determine the respective Exhibiting Circuits.
- (4) The Chairman shall determine from time to time the Cinemas, which come under each Exhibiting Circuit.
- (5) Exhibiting Circuit other than the Corporation shall be established under regulation 3 depicted below.
