Land Reform Law No. 1 of 1972

ORDER UNDER SECTION 27 (A) (4)

BY virtue of the powers vested in me by Section 27 (A) (4) of the Land Reform Law, No. 1 of 1972 as amended by Law No. 39 of 1975, 14 of 1981, 39 of 1981, 14 of 1986 and 18 of 1986, I, Mahinda Rajapaksa, President of Democratic Socialist Republic of Sri Lanka in pursuance of the Provisions of the said Land Reform Law as amended and the terms and conditions of the order under Section 27 (A) (1) of the Land Reform Law No. 1 of 1972 vesting the land specified in that order as described in Schedule I hereto in the State Plantation Corporation established under the Act, No. 4 of 1958 and published in the *Gazette Extraordinary*, Part I : Section (I) – General No. 815/10 of 21.04.1994 of the Democratic Socialist Republic of Sri Lanka, do hereby revoke the order pertaining to the extents of lands described in Schedule II hereto.
