**FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE POLPITHIGAMA PRADESHIYA SABHA
UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)**

WHEREAS the office of a member in Polpithigama Pradeshiya Sabha has fallen vacant by reason of death ;

And whereas the Secretary of the United People's Freedom Alliance, the recognised political party to which Meragal Pedi Durayalage Gunarathna Banda, the member belonged, was required by me under Section 65A (2) of the aforesaid Ordinance, to nominate a person eligible under the Ordinance for Election as a member of that Polpithigama Pradeshiya Sabha who belongs to such party who shall be declared elected as a member within a period of thirty (30) days ;
