Revocation of Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Urban Development Projects (Special Provisions) Act, No. 2 of 1980, I, Mahinda Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka upon the recommendation of the Minister-in-charge of the subject of Urban Development, proclaimed by Gazette Extraordinary No. 1473/30 dated 01.12.2006 that the lands specified in the Schedule given below were urgently required for the purpose of carrying out a President Square Project under and Urban Development Project.
