TOWN AND COUNTRY PLANNING ORDINANCE (CHAPTER 269)

Order under Section 6(2)(b) and Section 21 (2)(b)

BY virtue of the powers vested in me by Section 6(2)(b) and Section 21(2)(b) of the Town and Country Planning Ordinance (Chapter 269), I, Dinesh Chandra Rupasinghe Gunawardena, Minister of Urban Development and Sacred Land Development, do by this order :-

- (a) declare that the area of land specified in the Schedule hereto shall be an urban development area for the purpose of the aforesaid Ordinance and shall be called the “Tissamaharama Sacred Area” ; and
- (b) direct that an outline scheme shall be prepared for the whole of the area declared to be the Tissamaharama Sacred Area.

SCHEDULE

THE AREA OF LAND COMPRISING THE TISSAMAHARAMA SACRED AREA

The areas of land containing in an extent of 31.940 Hectares shown by the Survey-General's Tracing No. H/TSS/2007/516 dated October 19th, 2007 and situated in Grama Niladhari Divisions of Thihawa North, Thihawa South and Ranakeliya North within the Divisional Secretary's Division of Tissamaharama in the Administration District of Hambantota in the Southern Province and bounded as follows :-

North : by Lot No. 57 of Final Village Plan No. 623 and Lot No. 18 of Final Village Plan No. 630 ;

East : by Lot Nos. 18, 19, 45 and 41 of Final Village Plan No. 630 ;

South : by Lot Nos. 45, 41 and 31 of Final Village Plan No. 630 and Lot No. 10 of Final Village Plan No. 634, the Road Development Authority road, the Hambantota - Kirinda main road and Lot No. 57 of Final Village Plan No. 623 ; and

West : by Lot Nos. 41, 45 and 31 Final Village Plan No. 630, the Hambantota - Kirinda main road, the Road Development Authority road and Lot Nos. 57 and 43 of Final Village Plan No. 623 .
