#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Jeewan Kumaranatunge, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Allotments of land depicted as Lot Nos. 1-5 in the advance tracing No. CO/HNW/2007/205 dated 19.07.2007 made by the Superintendent of Surveys and situated in the village of Ukwatte in the Divisional Secretary's Division of Sithawaka (Hanwella) Colombo District and containing to total extent of 0.3654 Hectare and bounded as follows:
