##### THE LAND ACQUISITION ACT (CHAPTER 460)

###### Declaration under Section 5

I, Janaka Bandara Tennakoon, Minister of Land and Lands Development, hereby declare under sub-section (1) of section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Two (2) allotments of land called Citruswatta in extent of about 0.1627 Hectare, as Lot “A” and “B” depicted in Advance Tracing No.GA/BDD/10/191 and dated 16.08.2010, prepared by the Surveyor General situated in village of Pahalakeembiya, in the Divisional Secretary’s Division of Baddegama in Galle District in Southern Province and bounded as follows:
