SRI LANKA EXPORT DEVELOPMENT ACT, No. 40 OF 1979

Order under section 14

BY virtue of powers vested in me by section 14(1) of the Sri Lanka Export Development Act, No. 40 of 1979, I, Rishad Bathiudeen, Minister of Industry and Commerce with the concurrence of the Minister of Finance and Planning, do by this order declare that with effect from 05th March, 2011, a Export Cess shall be charged, levied and paid on export of goods enumerated in Column III of the Schedule hereto at rates specified in the corresponding entry in Column IV, notwithstanding any order already made for the purposes of aforesaid section.

Wherever more than one rate is specified in Column IV of Schedule hereto the applicable rate for the purpose of calculating the Cess payable shall be that rate the application of which results in a higher amount being payable as Cess.
