#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Tennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Three (3) allotments of lands in total extent of about 0.8631 Hectare prepared by the Surveyor General depicted as Lots “A”,
