### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Tennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Allotments of land in total extent of about 0.0943 Hectare, depicted in Advance Tracing No. Gam/Biya/2010/428 of 27.01.2011, prepared by Surveyor-General, situated in the village of Wathurapana, in the Minor Division of Adikari Pattuwa, in the Divisional Secretary's Division of Biyagama in Gampaha District in Western Province and bounded as follows.

##### 01. Lot 'A' – Elukwatta – Extent: 0.0818 Hectare

North: Road (RDA); East: Land claimed by Road Development Authority; South: Land claimed by Road Development Authority, Kelani river, balance portion of this land; West: Land claimed by A. A. Abeysinghe Weerathna.
