THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Tennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Nine allotments of lands called Anhendiya Kumbura (Marked as Lots A, B, F, K, L, M, N, P, and Q) in total extent of about 0.5007 Hectare, depicted in Advance Tracing No. Maha/HTR/2010/294 and dated 03.09.2010, prepared by the Surveyor-General, situated in the village of Hatharaliyadda, in the Divisional Secretary's Division of Hatharaliyadda (F. V. P. 204), Sub Division of Pallepalata Korale in Kandy District in Central Province and bounded as follows:

Declaration under Section 5

I, Janaka Bandara Tennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.
