THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a extension of the Katharagama New Development Zone and will be acquired under the provisions of that Act.

Twenty (20) allotments of land in total extent of about 9.748 Hectares, depicted in Advance Tracing No. MO/A/87/28 prepared by the Surveyor-General situated in the Village of Katharagama in the Divisional Secretary's Division of Katharagama in Monaragala District and bounded as follows:
