STATUTORY DETERMINATION UNDER SECTION 19 OF THE LAND REFORM ACT, No. 01 OF 1972

MR. Bertholameus Dias Abeywickrama Gunasekara who has given the address “Sea Veiw, Habaraduwa” has made a statutory determination under Section 18 of the Act, and since he has demised, by virtue of the powers vested in the Land Reform Commission under Section 19 of the Act, a statutory determination has been made by the Commission as per the testamentary determining the portion of agricultural land which the statutory Tenant should be allowed to keep. The portions of agricultural land which the tenant was allowed to keep are indicated in the following Schedule.
