THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon Minister of Lands and Land Development, hereby declare under Sub section (1) of Section 05 of the Land Acquisition Act that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.
