CENTRAL PROVINCE PROVINCIAL COUNCIL

By Laws of Ududumbara Pradeshiya Sabha

IT, is hereby notified that I, Sarath Ekanayake, as the Minister in charge of the subject of Local Government in the Central Province, by virute of powers vested in me under Sub-Section (1) of the Section 123 of Pradeshiya Sabha Act, No. 15 of 1987 to be read with Sub Section (1) of Sub-Section 2 of the Provincial Council Act, No. 12 of 1989 (Consequential Provisions) has approved the under mentioned By-Laws framed by Ududumbara Pradeshiya Sabha, according to power vested in the said Pradeshiya Sabha under paragraph (4) Sub-Section VII of Section 126 of the said Pradeshiya Sabha Act, No. 15 of 1987 to be read with Subsection 1 of Section 122 of the said Act, and the Ududumbara Pradeshiya Sabha authority area from the date of publication of this notification in the Government Gazette.

Further, the approved By-Law No. 06 framed for the purpose of parking motor vehicles as set out in the approved By-Laws of the Government Gazette Extraordinary, No. 520/7 of 23.08.1988 complied by the Minister of Local Government, Housing and Constructions is rescinded from the date of coming into operation of the aforesaid By-Laws within the Ududumbara Pradeshiya Sabha authority area from the date of publication of this notice in Government Gazette.

BY-LAWS REGARDING TO PARKING OF HIRING MOTOR VEHICLES
-UDUDUMBARA PRADESHIYA SABHA

1. These By-Laws are framed in terms of the powers vested by Section 122 and 126 (vii) (hi) of the Pradeshiya Sabha Act, No. 15 of 1987.

2. These By-Laws are known as By-Laws to control, regulate supervise, and charge of hiring motor vehicles, within the administrative limits of Ududumbara Pradeshiya Sabha.

3. These By-Laws approved by the Minister, will be effective from the date of publication in the Gazette of Democratic Socialist Republic of Sri Lanka.

4. No Hiring vehicle shall be parked in any place, other than the places denoted in the first Schedule and approved by the Council and fixed by the Chairman such places may be decided by means of a resolution of the Council.

5. For parking hiring vehicles in the places reserved in terms of By-Laws III within the administrative limits of Ududumbara Pradeshiya Sabha, a fee in terms of Schedule Two, Shall be paid monthly to the Pradeshiya Sabha. Such fees should be fixed from time to time, by resolution of the Council.

6. No person shall park a hiring vehicle, in any place which is reserved as a parking place, in the administrative area of the Pradeshiya Sabha (with amendments) without a permit issued by the Chairman of the Pradeshiya Sabha of any other officer duly authorized by him and it is effective from 5.00 a.m. to 7.00 p.m.

7. A permit issued under these By-Laws for any month will lapse on last day of the month, in which it is issued unless it is earlier cancelled by the Chairman or any other officer who has been authorized by him.

8. An application form as per third Schedule for a permit shall be submitted to the Chairman. Application form can be obtained from the office of the Ududumbara Pradeshiya Sabha, and all the such applications.

9. The owner or the driver of any hiring vehicles parked at a common parking place, shall forward the permit when called upon to do so for inspection by a police officer or traffic warden or any person duly authorized by the chairman.

10. Before first week of every month, a permit to park hiring vehicles, shall be obtained at a time only one permit which is valid for a month will be issued.

11. Except the Motor Vehicles that are presently registered with the Council any other Motor Vehicle is to be parked in a common parking place. Must be made an application to the Council and a permit must be obtained before parking.

12. Any Motor Vehicle ceased to park in a parking place or temporary ceased to park for more than two weeks due to repairs the office must be informed if such information is not given the relevant monthly fees must be paid.

13. No Motor Vehicle shall be repaired at the hiring car stand and vehicles shall be parked without obstructing the other vehicles.

14. No person shall wash or caused to be wasted a vehicle parked in any common parking place.

15. No person shall behave while being drunk in a common parking place or in a hiring vehicle parked in a common parking place or behave in a disorderly manner to be a hindrance to others.

16. Any person who contravene any of these By-Laws from 1 to 15 if convicted by a competent court of jurisdiction is liable to a fine not exceeding Rs. 750 and in the event of continued contravention the Chairman or any other officer duly authorized by him by giving a written notice regarding the continued contravention, he is liable to a further commission or the offence, fine should be credited to the Pradeshiya Sabha Council fund.

17. In addition to the fine, ordered by a competent court of jurisdiction, any person who is convicted for more than twice for contravention of these By-Laws, the permit issued to him is liable to be cancelled and no compensation can be claimed by the permit holder.

18. In these By-Laws,

‘Council’ Means	Ududumbara Pradeshiya Sabha
‘Chairman’ Means	Chairman of Ududumbara Pradeshiya Sabha
‘Authorized Person’ Means	Person authroized in writing by the Chairman of Ududumbara Pradeshiya Sabha to issue permits for hiring vehicle parks.
‘Motor vehicles’ Means	Mechanically manufactured vehicles driven on roads such as three wheels, lorries, vans, tractors, trucks, cars and two wheel-tractors.
