THE LAND REFORM LAW, No. 1 OF 1972

Order under Sub-section (4) of Section 27A

BY virtue of powers vested in me by Section 27A (4) of the Land Reform Law, No. 1 of 1972 as amended by the Land Reform (Special Provisions) Act, No. 39 of 1981, read with Article 44(2) of the Constitution of the Democratic Socialist Republic of Sri Lanka, I, Mahinda Rajapaksa, President, do hereby -

- (a) amend the Order, made under Section 27A (1) of the Land Reform Law, No. 1 of 1972 and published in *Gazette Extraordinary* No. 517/20 of August, 05, 1988 relating to the estate land called and known as Galaha morefully described in the First Schedule to this Order and which has been vested in the Janatha Estates Development Board established under the State Agricultural Corporations Act, No. 11 of 1972, by revoking on grounds of non-compliance with the terms and conditions relating the consideration for the vesting in such Board, such portion of the said Order as relates to the extent of Land called Galaha (Malberry Division) specified in the Second Schedule hereto ; and
- (b) state that upon revocation, such extent of land as specified in the Second Schedule to this Order, shall re-vest in the Land Reform Commission.
